## Unaatuq, LLC Purchases Pilgrim Hot Springs

Bering Straits Native Corporation (BSNC) announced that a consortium of Native and non-profit entities from the Bering Straits region were the successful bidders for Pilgrim Hot Springs, a property owned by the Catholic Bishop of Northern Alaska (CBNA). Pilgrim Hot Springs was auctioned for \$1.9 million in US Bankruptcy Court as partial fulfillment of the obligations of the CBNA in its bankruptcy proceedings. Unaatuq, LLC, the successful bidder, is owned by BSNC; Sitnasuak Native Corporation; Kawerak, Inc.; Norton Sound Economic Development Corporation; White Mountain Native Corporation; Teller Native Corporation; and Mary's Igloo Native Corporation (MINC). "Unaatuq" is an Inupiaq word that generally means "warm water."

Pilgrim Hot Springs is located on the left bank of the Pilgrim River, 13 miles northeast of Salmon Lake, which is 38 miles north of Nome. It was the site of a gold rush resort and later a Catholic mission and is listed on the National Register of Historic Places. In the days of gold mining on the Seward Peninsula circa 1900, the property was known

## BSNC's Shareholder Turns 100 Years Old

A 100th year birthday celebration was held for BSNC shareholder Frances Johnson at the Munaqsri Senior Apartments in Nome by her children on April 23.

Frances was born to Eunice and Matthew Kokochuruk in 1910 at Atnik, a remote village on the shore of Golovin Bay. Not knowing her exact date of birth she was officially assigned April 23, 1910 as her birth date. Frances credits her longevity to a lifelong trust and faith in God as well as living a healthy diet of fish, marine mammals, waterfowl and their eggs, as well as a wide variety of greens and berries.

Despite being stricken as a toddler by polio she overcame it and many other catastrophic illnesses. She survived a bout with cancer and encouraged and supported women to seek early treatment for cancer by being a speaker in two videos, "Breast Cancer Awareness Month" and "Stories of My Sisters."

Frances was raised in a traditional lifestyle. She grew up doing a "man's work" by driving dog teams, hunting game animals, seining for fish, working in the local saltry,

# BSNC Greetings

Gail Schubert, CEO

Spring is just around the corner, and the longer daylight hours we now have are a thankful reminder of that. Soon, people in the Region will be out bird hunting and gathering eggs, a tradition we have carried on for thousands of years, and before we know it Summer will be in full swing. We are gearing up for what we hope will be a productive construction season in the Region. The Nome Hospital appears to be on track and our partner Neeser Construction already has a construction crew in Nome erecting the steel frame for the new hospital. Our subsidiary Inuit Services will provide a variety of services for the project, including camp management (housing for the workers) and dining services, project administration services, oversight of the electrical contractor, the safety and Indian liaison officer, and final cleaning of the construction arena. We expect the hospital to be substantially complete by November 2012.

The BSNC Board of Directors just completed its second annual strategic planning and training conference, and adopted a three year Strategic Plan at the end of the conference. The Board worked closely with staff to develop and refine the Strategic Plan. The Plan includes three core strategies: to diversify our revenue, enhance shareholder opportunities, and increase our net income. As many of you know, BSNC is currently very dependent on government contract revenues. Given the ongoing efforts to restrict ANCSA corporation participation in the SBA 8(a) Program, the Board and management recognized the need to diversify our revenue base in the event that efforts to change the program are successful. Staff will continue to work with the Board in the implementation of the Strategic Plan, which we believe will result in increased growth and stability for BSNC.

We are also pleased to announce that a consortium of Alaska Native for-profit and non-profit entities from the Bering Strait Region were recently the successful bidders to purchase approximately 320 acres of land in and around Pilgrim Hot Springs. The consortium formed Unaatuq, LLC, an Alaska limited liability company whose name means 'warm water' in Inupiaq. The other consortium members include Sitnasuak Native Corporation, Kawerak, Inc., Norton Sound Economic Development Corporation, Mary's Igloo Native Corporation, Teller Native Corporation, and White Mountain Native Corporation. BSNC has long had an interest in the property because of its tremendous cultural and historical significance for the residents of the Region, and potential for agricultural and geothermal development and tourism.

Finally, the United States Congress is now considering legislation to ratify BSNC's land entitlement under Section 14(h)(8) of ANCSA. The Salmon Lake Land Ownership Consolidation Agreement, which BSNC land staff have worked on for many years, is a joint agreement among BSNC, the United States Government and the State of Alaska. If the legislation is passed, it will allow the BLM to finalize conveyance of land to BSNC, including lands in the Salmon Lake, Windy Cove and Imuruk Basin areas. Given the fact that all three parties have reached what they consider to be a fair and reasonable resolution of difficult land issues, we are hopeful that the Congress will pass this important legislation.

I hope that you all have a good and productive Spring, and look forward to providing you with updates on staff efforts to meet the milestones established by the Board in its recently adopted Strategic Plan.

and trapping fur bearing animals. She tanned the furs to use in traditional garment marking. She harvested and learned to preserve all the subsistence resources available in her region and shared this knowledge with her children, grandchildren, and anyone willing to learn.

Her hands were never idle. She is an accomplished seamstress and crafter, whether her medium was skins, fabric, yarn, beads, or threads. She learned these skills from her mother Eunice. She fashioned seven traditional fur dress parkas and two of her parkas received awards in Alaska.

Frances is trilingual in speaking Inupiaq, Yupik, and English. She also understands Canadian and Greenland Inuit dialects when spoken to her. She's a teller of many Inupiaq legends, stories, and songs. Frances translated many hymns into Inupiaq, which she sang in the Evangelical Covenant Church.

Frances was named Mrs. Arctic Native Brotherhood Queen in 1982 in Nome. In 1991 she was the recipient of Elder of the Year for Council Native Corporation and BSNC for sharing and passing on the knowledge of the cultural traditions of her people.

Frances and Albert A. Johnson, of Council, got married in 1933 and they raised eight children. Frances' children include Johnny Johnson and Pearl Johnson of Nome, Carolyn Schubert and Fran Miller of Anchorage, and Clarence Waghiyi of Savoonga. Her children Wallace Johnson Sr, Allan Johnson Jr, and Loretta Willoya are deceased.

as Kruszgamepa Hot Springs and was a recreational center for miners who were attracted by its spa baths, saloon, dance hall and roadhouse. The roadhouse and saloon burned to the ground in 1908. The property was then given to Father Bellarmine Lafortune and construction began on the mission in early 1918. In October 1918, the influenza pandemic hit the region, taking nearly half of the Native population between the villages of Unalakleet to the south and Shishmaref to the north. Many of the children who survived were raised at the Mission. The Catholic Church operated the Mission until 1941, housing up to 120 children. Ruins of the Mission school and other church properties remain on the site.

BSNC has long sought an interest in the Pilgrim property, which is a 320 acre in-holding in a large swath of lands owned by BSNC and MINC. The property has tremendous cultural and historical significance for the residents of the region and many families trace their ancestry to relatives who were raised at the Catholic orphanage. For centuries, hot springs in the region have been visited for the curative powers and strong spiritual associations.

"The acquisition of this property represents a victory at many levels," BSNC CEO Gail Schubert said. "The property is now back under the stewardship of stakeholders from the Bering Straits region, both Native and non-Native. It has great potential as a place of cultural renewal and healing, and agricultural and geothermal development. We are grateful that the residents of the Bering Straits region will be able to benefit once again from the ownership by Unaatuq, LLC which collectively represents all of the shareholders, tribal members and other residents of the region."

## Green Energy Solutions: An alternative energy store

Bering Straits Development Company, a wholly owned subsidiary of BSNC, opened a retail store called Green Energy Solutions in December 2009. Green Energy Solutions is starting out with a small amount of items and as the sales grow it will provide more alternative energy products that will help people save on energy costs.

Several large sales have put the title of the retail store as Manufactures Representative for the State of Alaska. One example is the replacement of the Christmas lights on Front Street in Nome. The Nome Volunteer Fire Department's Lighting Committee took the initiative to research and test some

LED bulbs. "While the initial purchase cost of LED bulbs is more than standard incandescent, the electricity used is cut by 96%," said John Handeland, NJUS Utility Manager. The annual operating cost for the new lights is estimated to be \$800, which is a saving of \$19,000 per year in electricity costs.

Nome Beltz High School recently purchased and installed LED tubes to replace lighting in the classrooms and offices. LED tube lighting produces excellent color quality and appears clear and consistent over time. When you turn LED lights on you instantly get light and they don't use power when turned off, except with the

external controls, whose power should not exceed 0.5 watts in the off state.

Green Energy Solutions has various light bulbs in stock. Compact fluorescent light bulbs, or better known as CFLs, need a little more energy when first turned on, but once the electricity starts moving, they use about 75% less energy than incandescent bulbs. LED (light-emitting diode) lighting is more efficient, durable, versatile and longer lasting than incandescent and fluorescent lighting. LEDs emit light in a specific direction, whereas an incandescent or fluorescent bulb emits light and heat in all directions. LED lights do cost more than CFLs.

## Banner Wind Power Purchase Agreement Signed

Nome Joint Utility Systems (NJUS) has entered into a power purchase agreement with Banner Wind, LLC, a partnership between Bering Straits Native Corporation (BSNC) and Sitnasuak Native Corporation (SNC), which provides wind power from eighteen (18) 50kw turbines.

Since the wind farm went into production, a total of 654,000 kilowatts have been provided to the NJUS grid. So far, NJUS said that 41,000 gallons of diesel has been avoided based on the average calculation that one gallon of fuel produces 16 kilowatts of energy.

## Hospital Replacement Project Jobs

Inuit-NCI JV has started to erect the steel structure. The workforce is expected to increase once the first barge has landed in Nome, which is anticipated to arrive in mid-June.

NEC will be referring qualified Alaska Native and American Indian applicants to the NSHC Hospital Replacement Project Contractors and Sub contractors. NEC has no hiring authority.

If you've not applied, you may do so by calling Dora Davis or going to [www.necalaska.com](http://www.necalaska.com) to obtain a Hospital Replacement Project job application and submitting it to Nome Eskimo Community.

The maximum number of individuals employed at the peak of the project is anticipated to be 75. This includes positions such as sheet metal workers, medical equipment installers, crane operators, ironworkers, etc. It's expected to have a maximum of 14 laborers, however the workforce will fluctuate throughout the project depending on need.

As the project continues, more opportunities may become available for positions such as line cooks, camp services personnel, and janitorial services. Please check back with NEC for updated job opportunities.

Financial assistance for relocation may be available for regional residents through Kawerak, Inc. for those who are selected to work. To inquire about relocation assistance call Kawerak at 1-800-450-4341.

## Do You Have a BSNC ANCSA Stock Will?

When a Shareholder passes away without having executed a BSNC ANCSA stock will, the shares will be transferred to heirs in accordance with the laws of intestate succession under Alaska Statutes. This segment of the Alaska Statutes is very specific in determining the inheritors of stock. The end result may not exactly reflect what the Shareholder may have verbally stated to family members or friends. The method for making sure your stock goes to whom you want it to go is to complete a BSNC ANCSA stock will form. With this form you can designate exactly whom you want your stock transferred to when you pass on.

A Shareholder can update their stock will at any time. For example, as time goes on, you may have additional

children you want to add to your will, or you may want to delete someone from a previous will. When determining inheritance, the most recent (latest dated) valid will specific to the disposition of stock will determine who inherits your shares.
