Seattle Area Shareholder Meeting

BSNC held an informational meeting for its Shareholders in the Seattle area on April 17. BSNC has approximately 390 Shareholders in the state of Washington and 233 people attended the informational meeting, which was an impressive turnout.

The Northwest Inupiaq Dancers began the meeting by welcoming the Board of Directors and staff and performing a few Eskimo dances. Chairman Henry Ivanoff welcomed all in attendance and the Board of Directors and staff were introduced. Gail Schubert, President and CEO, gave her report on BSNC and subsidiary operations, Wally Powers presented a financial report, and Matt Ganley reported on Land and Resource activities. Staff answered questions for the Shareholders. Director Steve Ivanoff presented a slide show and talked about his family living in Unalakleet and doing subsistence hunting and fishing activities.

Gladys Armstrong, who resides in Tacoma, was recognized as a recent recipient of the Elder of the Year from Golovin Native Corporation. The crowd gave her a standing ovation. Door prizes were drawn. Afew of the Shareholders expressed their gratification for winning dry and smoked fish or BSNC jackets and vests, as they hadn't been home for some time. The Northwest Inupiaq Dancers performed again and invited the Board and staff to dance with them during the last song. See pictures on page 3.

Tahbone Crowned Miss Indian World

Marjorie Linne Tungwenuk Tahbone, a Bering Straits Foundation Scholarship recipient, was crowned Miss Indian World for 2011. She competed with 25 fellow indigenous ladies, including contestants from Canada and fellow Inupiag Elizabeth Rexford from Anchorage, at the annual Gathering **Nations** of held the end of April. The Miss Indian World pageant originated 1983 in Albuquerque, New Mexico. Indigenous, young women from all over North America compete for this



most prestigious crown. Marjorie was selected as the most rounded woman after being judged in a traditional talent presentation, public speaking, private interviews with the judges, and a dance competition to powwow music.

Marjorie did her talent presentation on Traditional Native Games. She demonstrated the One-Arm Reach and the One-Foot high kick and explained how important these

Greetings from the President & CEO

Spring is finally here and it's time for Spring subsistence activities to begin in our villages. As leads open in the ice, some hunters will head out to sea looking for walrus, oogruk and other kinds of seal, while other hunters will start hunting migratory birds that return to our region to nest. When the birds start nesting, that provides another good Springtime staple in many of our homes — bird eggs. Spring hunting gives us the opportunity to replenish our food supplies while we enjoy engaging in the subsistence activities that have sustained us for thousands of years.



The BSNC Board recently hosted a shareholder information meeting in the Seattle area, which was a tremendous success. We had approximately 233 shareholders who attended,

some of whom had moved from our Region more than fifty years ago. They appreciated the opportunity to meet with the Board and each other, and get an update on our operations and finances. We were fortunate to have an Inupiat dance group, led by Thomas Octuck, Sr., perform for us. In addition, we had two shareholders who were over ninety years old who attended the information meeting. We learned that many had watched our last annual meeting over the internet when we webcast it for the first time ever, and expressed strong support for webcasting future annual meetings. We intend to webcast all our future annual meetings. In addition we plan to implement online voting so that our shareholders can vote their proxies online for the next annual meeting in October. More information on the process for online voting will be provided closer to the date of the annual meeting.

BSNC's major source of revenues continues to be earned from the SBA 8(a) and Small Business Programs. Alaska Native Corporation participation in the SBA 8(a) Program continues to face repeated attacks from certain members of Congress who wish to bar our participation in the Program. Given the importance to BSNC of government contract revenues, management has been very active in efforts led by the Native American Contractors Association and the Alaska Federation of Natives to help defend our participation in the 8(a) Program. Thanks in part to revenues earned from our government contracting efforts, we recently pledged \$200,000 to the Kawerak Cultural Center which will be constructed in Nome. We also significantly increased our contributions to the Northwestern Alaska Career and Technical Center and the Bering Straits Foundation, in support of shareholder and descendant education and training. The recently adopted shareholder bereavement program is also supported by earnings from government contracting. This program provides original shareholders and certain of their family members with a \$500 bereavement payment to help cover funeral expenses, and has proven very helpful to our families in need. Almost 100 families have received assistance under the bereavement program since its adoption.

May is graduation month, and on behalf of BSNC staff and the Board of Directors, I would like to extend our sincere congratulations to our shareholders and descendants who are graduating from high school, college, and graduate school. We are all proud of your accomplishments.

I would also like to congratulate the newly crowned 2011-2012 Miss Indian World Marjorie Tahbone, who will be the tribal ambassador for more than 500 different nations in the continental U.S., Alaska, Hawaii and Canada for the next year. She sealed her win with a demonstration of Alaska Native games, including the one-arm reach and one-foot high kick, explaining that the games were traditionally important for survival and strength. Marjorie is a student at the University of Alaska Fairbanks double majoring in Biological Sciences and Alaska Native Studies with a minor in Inupiaq language in Alaska Native Studies, and a Bering Straits Foundation scholarship recipient. She is of Inupiat and Kiowa Indian heritage, and the daughter of Sandy Tahbone, a BSNC shareholder, and Carlton Tahbone, of Nome.

Shareholder Christian Leckband signed a National Letter of Intent to play basketball with the Seawolves at the University of Alaska, Anchorage (UAA) on May 4. He is the Seawolves' first recruit for this upcoming season. UAA is a NCAA Division II school that competes in the Great Northwest Athletic Conference (GNAC). Other GNAC institutions are Western Washington, UAF, Western Oregon, Simon Frasure, Northwest Nazarene, Central Washington, Seattle University, Saint Martin's University, and Montana State-Billings.

Christian started playing basketball when he was six years old. When he moved to Nome, at the age of 11, he got more serious about the sport. His seriousness and dedication to the sport of basketball has definitely paid off as he earned a spot on the Seawolves team and the opportunity to obtain a higher education. While at UAA, Christian plans on obtaining a degree in Human Services. After obtaining his degree he'll further his education by going to Physical Therapy school to become a Physical Therapist.

"I am very excited to join the Seawolves. I've had a lot of interest in them since my junior year; I like all the coaches and had the opportunity to meet most of the players. They are a great group of guys and I can't wait to join the family," said Christian.

Christian played with the Nome-Beltz Nanooks varsity team for the last three years. He has helped lead the Nanooks to a 70-17 record and three straight State Tournament appearances. Christian's senior year was an awesome year for him on the court. He was selected to the All Tournament teams at the following tournament: ACS, Subway Showdown, Alaska Airlines Classic, Alaska Prep Shootout, Valdez Tournament, and the Western Conference Tournament. Brian Randazzo, Jr. broke the Native Youth Olympic (NYO) record for the two-foot high kick when he kicked an impressive 8 feet and 5 inches on April 30. Many of you probably know of the other Brian Randazzo, Sr., his father, who holds the world record for the two-foot high kick at 8 feet and 8 inches. Brain Sr. is a legend himself and now his son is following his footsteps.

Brian Jr. learned Native games as a young boy and participated in the Junior NYO events during elementary school. He quit playing for a while and recently, during his senior year in high school, started again. This past November he enrolled in the Alaska Native Heritage Center After School Native Games program. There, he discovered his ability to high kick with the help of his coach, Casey Ferguson of Chevak. In January 2010 he won the one-foot high kick at the Alaska Native Lutheran Church's New Year's Eve gathering. At the Anchorage NYO Preliminaries this past March he earned his place on the Anchorage NYO Team.

At the 2011 Statewide NYO competition Brian Jr. earned the gold medal in the one-foot high kick, reaching 9 feet and 3 inches, and in the Indian Stick Pull as well as receiving the Outstanding Male Athlete Award and the Male Sportsmanship Award.

Brian's parents couldn't be prouder of their son's recent accomplishments in Native games. "Brian's high kicking abilities have been a wonderful, unexpected gift that our son has been given. We are grateful to God for his athletic talents. We know that they will help him to grow into a confident and strong young man," said Brian's mother Sheila.

With good reason Brian Jr. is excited to participate in a variety of Alaska Native game venues throughout the future, including World Eskimo Indian Olympics and Arctic Winter Games. "He is happy for his new found gifts. He is young and has much to learn. We will see where his Native games talent will take him," said his mother.

Brian's mother, Sheila Randazzo, is a BSNC Shareholder with family roots from Shishmaref. Her mother is Lorena Seetomona and her grandparents are Tommy and Glenna Seetomona.

The end result may not exactly reflect what the Shareholder may have verbally stated to family members or friends. The method for making sure your ANCSA stock goes to whom you want it to go is to complete an ANCSA stock will form. With this form you can designate exactly whom you want your stock transferred to when you pass on. BSNC has

Updating ANCSA stock wills

A Shareholder can update their ANCSA stock will at any time. For example, as time goes on, you may have additional children you want to add to your will, or you may want to delete someone from a previous will. When determining inheritance, the most recent (latest dated) valid will specific to the disposition of ANCSA stock will determine who inherits your shares.

Board Contributes to \$300,000 to NACTEC

The BSNC Board of Directors recently contributed \$300,000 to Northwestern Alaska Career and Technical Center (NACTEC). NACTEC is a joint-venture regional vocational training center designed to provide Bering Strait School District and Nome Public Schools high school students with the necessary resources and skills for employment opportunities, the pursuit of postsecondary education, and independent living skills through instruction in four focus areas: career and technical skills, career exploration, life skills, and work readiness skills.

NACTEC recently held a session on Renewable Energy "Going Green." Six high school students built a wind turbine, studied solar panels with photo-voltaic cells, rejuvenated batteries and stored their own electricity, learned how AC/DC current works and how it applies to renewable energy.

With the cost of electricity running about \$0.35 per Kilowatt Hour (KwH) in Nome, and even higher in surrounding villages on the Seward Peninsula, the need for alternate forms of energy are in demand. NACTEC will continue providing Renewable Energy career exploration opportunities and then connect students with post-secondary training programs to build a regional workforce for jobs that are currently outsourced. Trained technicians in every village would be a wonderful outcome.
