## BSNC purchases Alaska Gold Co.

BSNC is pleased to announce that on November 1, Alaska Gold Co. (AGC) was purchased from NovaGold Resources. AGC was a wholly owned subsidiary of NovaGold Resources, when it was purchased in 1998.

The transaction was the result of more than 18 months of negotiations between BSNC and NovaGold concerning the reclamation of the Rock Creek Mine and the potential for future gold production at the site. BSNC's Board of Directors approved the purchase of AGC on Oct. 12, the day before this year's annual shareholder meeting. At the annual meeting Gail Schubert, BSNC President and CEO, reported to the shareholders that the AGC property and assets would provide a foundation for additional diversification of the Corporation's operations, particularly within the Bering Strait region.

The assets of AGC include the Rock Creek Mine facility, all patented mining claims in the Rock Creek and Big Hurrah project areas, certain real estate within the city limits of

## 2013 Annual meeting of shareholders

The BSNC Annual Meeting of Shareholders was held on Oct. 13, in Anchorage at the Alaska Ballroom in the downtown Hilton Hotel. About 250 shareholders attended the meeting and shareholders from 29 states viewed the webcast.

Elder of the year awards were presented to Mathias Pederson of Council Native Corp., Gabriel Amuktoolik from Golovin Native Corp., Rita Olanna from Brevig Mission Native Corp., Clara Topkok from Mary's Igloo Native Corp., Dina Sagoonick from Shaktoolik Native Corp., Vincent Tocktoo Sr. from Shishmaref Native Corp., Jacob Ahwinona of Sitnasuak Native Corp., Helen Curran Larsen of Solomon Native Corp., Rose Okbaok of Teller Native Corp. and Isaac Oxereok of Wales Native Corp. Twenty-five Early Bird prizes were awarded to shareholders whose proxies were received by Sept. 19.

Gail Schubert gave her President's Report and answered

## Dividend mailed in early December

The BSNC Board of Directors declared a shareholder dividend of \$2.50 per share at its regularly scheduled board meeting in August at Unalakleet. The typical shareholder owning 100 shares received a check in the amount of \$250 in early December.

BSNC showed record operating revenues of a little more than \$213 million for fiscal year ending March 31, 2012, an increase of \$15.5 million from 2011.

# *Greetings from the President and CEO*

As 2012 comes to a close, BSNC management and staff would like to wish our shareholders and their families a Merry Christmas and a safe and joyous New Year!

This past year was a busy year for BSNC in terms of growth and diversification of our business ventures. We continue to win new work in the government contracting arena despite increased pressures to reduce Alaska Native corporation participation in the 8(a) and small business programs. While some of our work is located in Alaska, we also perform work at various military installations in the Lower 48. Given our dependence on government contract work, management closely monitors developments in this arena both on the Congressional and on the agency levels.



During the annual meeting in October, management announced that BSNC planned to purchase Alaska Gold Company LLC (AGC), from NovaGold. That purchase was completed in early November. With the purchase, BSNC acquired significant commercial real estate in and around Nome, gravel resources, patented mining claims and all of the infrastructure at Rock Creek Mine. We have no plans to dismantle AGC, which will remain intact and spearhead mining and exploration efforts for BSNC. With our outside consultants, we are continuing to evaluate whether gold mining can be restarted utilizing our new mining properties. We have named the mine project Nanuuq Gold, and we expect to know within the next several months whether BSNC will engage in gold mining activities through AGC.

Another project we are pursuing, which will bring further business opportunities and economic development to the region, is the acquisition of Port Clarence, located on Point Spencer near the Bering Strait. This property was decommissioned by the U.S. Coast Guard in 2010, and we are seeking expedited ANCSA conveyance to BSNC through special legislation to be enacted by the U.S. Congress. We have worked closely with Alaska's Congressional Delegation to facilitate this conveyance. Beyond Port Clarence and the Rock Creek Mine, management will continue pursuing opportunities in our region designed to provide jobs and economic development for our shareholders, descendants and other residents of the region.

In the cold months ahead, I hope that all of us can take time to reflect on the many positive things that have brought us happiness and security. Many individuals have come before us to help pave the way, and we are thankful for the leadership and sacrifices they made to provide us with a better life and more opportunities. It is the path they laid and their skilled guidance that gives us our strength, just as our young leaders and youth provide the foundation for a bright future.

May you all be blessed in the coming year.

Nome and gravel and sand resources in and around Nome. Rock Creek Mine was constructed by AGC beginning in 2006 but failed to reach full production due to legal challenges and the faltering investment climate of 2008-2009. In 2011, AGC began the reclamation process at the mine site. BSNC has worked diligently with AGC to assess reclamation strategies and evaluate whether mining could proceed at some future date.

AGC will be retained as a wholly owned subsidiary of BSNC. Within the next several months, BSNC and AGC will determine whether the mine can be reopened or whether the property will be reclaimed.

## BSNC Shareholders receive AFN awards

### Roger Lang Youth Leadership Award

He then served as the sole youth representative at the annual meeting to recommend project proposals for the Beringia Program. His ideas and suggestions contributed toward benefitting the Beringia region in Alaska and Chukotka Russia. He is now a college freshman at the University of Alaska Fairbanks, majoring in Geological Engineering. Jacob is the son of shareholders Guy and Blue Martin of Nome.

and Zoe have raised their three children – Kelsi, Ralph and Gage – in a hybrid subsistence lifestyle. Together they are kept busy with various subsistence activities year-round, including hunting for caribou, moose, birds and seal hunting, picking berries and other vegetation, egg gathering, crabbing, fishing, gardening and much more. They value teaching their children how to properly take care of, put away and prepare food. Steve and Zoe embody the values of respect, tradition, hard work and cooperation and both have served on numerous regional and school boards in Alaska.

## A voting story

A number of Alaska Native corporation offices in Anchorage took advantage of the Get Out the Native Vote (GOTNV) Express to vote early this year as many of their employees grabbed a ride to the polls. At BSNC's Anchorage office a particularly inspiring story unfolded: Yuliya Temple, an employee in the accounting department, not only recently received her American citizenship, but she voted for the first time in her life.

Yuliya had worked in the Ukraine as an accountant for a construction company before coming to the U.S., and was hired by BSNC in March 2012. In the Ukraine, she didn't feel that her vote counted and was discouraged by what seemed like pre-determined outcomes in elections. She said that in the months leading up to

this election she worked hard to learn not just about the presidential candidates, but also about the ballot measures and candidates running in local elections. When asked to jot down some notes about her experience, she wrote the following:

"Growing up in Ukraine, I never really followed politics as it

## BSNC receives land from Salmon Lake Land Transfer

On June 15, President Obama signed legislation into law (P.L. 112-133) that resolved outstanding claims between BSNC and the State of Alaska in the area of Salmon Lake approximately 35 miles northwest of Nome.

This legislation was enacted after years of negotiations when a final agreement was entered into by BSNC, the State of Alaska and the U.S. Bureau of Land Management on July 18, 2007 to resolve competing claims held by the State and BSNC in the area of Salmon Lake, approximately 30 miles north of Nome, under the processes called for in the Alaska Native Claims Settlement Act (ANCSA).

A result of four years of discussions and negotiations, the agreement will facilitate the transfer of specific tracts of land to both the State of Alaska and BSNC and resolve outstanding issues in competing claims for the tracts. Lands of the BSNC are located in the far northwestern part of Alaska. Some are strategically located only two miles from Russia at their closest point.

The legislation authorizes the Bureau of Land Management (BLM) to convey the eastern portion of Salmon Lake to BSNC and the western portion to the State of Alaska in furtherance of the negotiated agreement reached

among all parties. The Act also allows conveyance of the Imuruk Basin Lands to BSNC. All of the lands included in the agreement benefit the people of the region for subsistence and recreational activities and provide critical habitat for various species of salmon, moose, caribou and other game resources. The long process of land selection, adjudication, and conveyance culminated through this bill that started with the passage of the ANCSA more than 40 years ago is nearly complete for the BSNC region and its member villages.

"Over the past three decades, following the processes set forth in ANCSA, BSNC has had to refine and prioritize the lands which were of the greatest value to the region's shareholders," said Gail Schubert, president and CEO of BSNC. Schubert noted that Salmon Lake was determined to be particularly important because of the reliance local residents have on the subsistence resources found there. The lake is one of the western most spawning areas for red salmon on the North American continent and has long provided an essential harvest for the people of the region. Caribou were once hunted in great numbers in the area and have recently returned. Salmon Lake also provides recreational opportunities

due to its location on the seasonal road that stretches north from Nome and the Bering Sea coast.

Schubert also noted, "Our elders have long understood the importance of this area to our people and our culture. While the process of securing these lands has been difficult at times, the future of BSNC and its shareholders, particularly with respect to subsistence activities and resources, will be enhanced and enriched by the receipt of the lands at Salmon Lake and Imuruk Basin for current and future generations. We want to thank Congressman Don Young for his dogged determination in getting this passed through the U.S. House of Representatives. We also want to thank Sen. Lisa Murkowski for sponsoring this bill in the Senate and getting it passed through the Senate Energy and Natural Resources Committee, on which she sits as ranking member. We also thank co-sponsor Sen. Mark Begich as well as Chairman Doc Hasting and Ranking Member Ed Markey for their support in getting this bill passed through the House Natural Resources Committee. We also thank the State of Alaska and the BLM for working with us in good-faith to finalize these lands claims that we have been working on since passage of ANCSA."
