Stock Will Drive, Your Chance to Win \$200

The BSNC board of directors recently approved a Stock Will Drive that provides a monthly drawing of \$200. The Stock Will Drive is an incentive for shareholders to have in their BSNC file a current Stock Will, whether it is a first one or a revised one. Each month BSNC will draw a lucky winner to receive \$200 from those shareholders that submit a new or revised Stock Will during the previous month.

Why Submit a Current Stock Will?

Some people find it easy to think about wills, while others prefer to avoid the subject entirely. *Having a Stock Will on file with BSNC lets you control who will inherit your stock after your death.*

If you die without a Stock Will, your stock will be distributed according to state laws, which may not be your intent or your wish. If you have a valid Stock Will on file, you control the decision on who will inherit your stock.

Some people use a simple approach and designate one person, perhaps a spouse to receive their entire stock while other people choose to divide their stock and give it to several people.

Shareholder Dividend to be Mailed in December

The BSNC Board of Directors declared a shareholder dividend of \$2.35 per share at its regularly scheduled board meeting on August 18 in Unalakleet. Most shareholders will receive a check in the amount of \$235 for owning 100 shares.

BSNC showed record operating revenues of nearly \$200 million for fiscal year ended March 31, 2011, an increase of \$12.5 million from 2010.

The dividends will be mailed in December. The Shareholder Department kindly requests that all address changes be received in the Nome office no later than November 15. A Shareholder Name and Address Change form is included on page 10.

Greetings from the President & CEO

Summer is a busy time of year for most of us, and I hope that everyone has had an opportunity to put fish and berries away for winter. This has also been a busy time for BSNC, and there have been several recent developments which impact our region and possibly our company.

First, NovaGold has moved forward with plans to deconstruct the Rock Creek mine located outside of Nome and reclaim the land. We have been working with Sitnasuak Native Corporation (SNC) management, external experts and lawyers to ensure that any reclamation that occurs at Rock Creek is done in a manner that protects the land and BSNC and SNC as landowners. SNC owns the surface estate, and BSNC is the subsurface owner of the land on which much of the mining facility is located. BSNC has a contractual preference under our lease agreement with NovaGold which gives us the right to perform certain work needed by that company. We intend to perform as much of the reclamation work as possible with one of our business partners.



Another major development has been the adoption by the Alaska Redistricting Board of the new electoral district boundaries in response to population changes determined by the 2010 U.S. Census. BSNC management closely followed the redistricting process, providing written and oral testimony at several redistricting hearings held around the state. We supported a plan for our region which included all of the villages in our region, St. Lawrence Island, and several villages on the Yukon which border our villages in the south. However, in part because of the requirements of federal law, our electoral district stretches from the west coast of Alaska to the Canadian border, and down along the border to the beginning of the southeast panhandle. It is the largest electoral district by land mass in the state, and the individuals who represent our region in the state Legislature will have a diverse population and wide variety of interests to represent.

BSNC has also participated in several meetings and hearings being held on the increasing amount of vessel traffic through the Bering Strait as the northwest passage opens due to the receding polar ice cap. Our villages border what is commonly referred to as the “choke point” in the Bering Strait because of the relatively narrow distance between our communities and the communities in Siberia. Our region has already experienced unexpected visits from large cruise ships, which are passing through the Northwest Passage in greater numbers each year than before. BSNC management has made this development one of our top priorities because we want to try to ensure that the subsistence practices of our villages are not destroyed by shipping and other traffic through the Bering Strait. While we can’t prevent vessels from traveling through the Strait, we can work to ensure that our concerns about the impact on subsistence hunting and fishing are heard.

There are also business and other economic opportunities that may arise from the eventual opening of the Northwest Passage to partial-year or even year-round traffic. Many of the other northern countries have already begun to construct the necessary infrastructure, such as ports, airports and roads, to prepare for the anticipated increase in shipping and other traffic through the passage. Our country has not yet identified the need for infrastructure development and therefore has not provided any funds for development. This may however present opportunities for private industry to invest in the necessary infrastructure, and BSNC is working to ensure that we take advantage of this opportunity. While the eventual opening of the Northwest Passage will present challenges to our region, it will also present opportunities for us.

BSNC staff hopes that everyone has a safe and enjoyable summer. Thanks very much for your continued support and interest in our corporation.

If you die without a Stock Will on file, Alaska state law will divide your stock as follows.

- **Married and have children**
Your stock will automatically transfer to your surviving spouse and children. Your spouse will receive 50% of your stock and your children will split the remaining 50%.
- **Married and do not have children**
Your shares would transfer to your surviving spouse. Your spouse would receive 100% of your stock.
- **Not married and do not have children**
Your shares would transfer to your surviving parent(s). Each parent would receive 50% of your stock or one surviving parent would receive 100%. If both parents were deceased your stock would be divided among your brothers and sisters.

Listed above are the simplest examples of transfer of stock according to state law. Quite often, transfers

I Need Proof of Native Blood

Many institutions that provide native services, especially in health care, require that you provide proof of native blood. We have had shareholders call our office stating that they need documentation in order to be seen at IHS health clinics.

We encourage all our shareholders and descendants to obtain a Certificate Degree of Indian Blood (CDIB) which is an accepted at all IHS facilities. This document is issued by the Bureau of Indian Affairs (BIA).

under state law require extensive research for surviving family members. Frequently family members cannot be found, making the transfer a lengthy process for everyone that can take years to complete.

If you already have a stock will on file with BSNC, you should review it periodically to make sure it reflects your current wishes. You should also review it when there has been a change that might affect your wishes as reflected in your current will such as death, marriage, divorce, birth, or adoption.

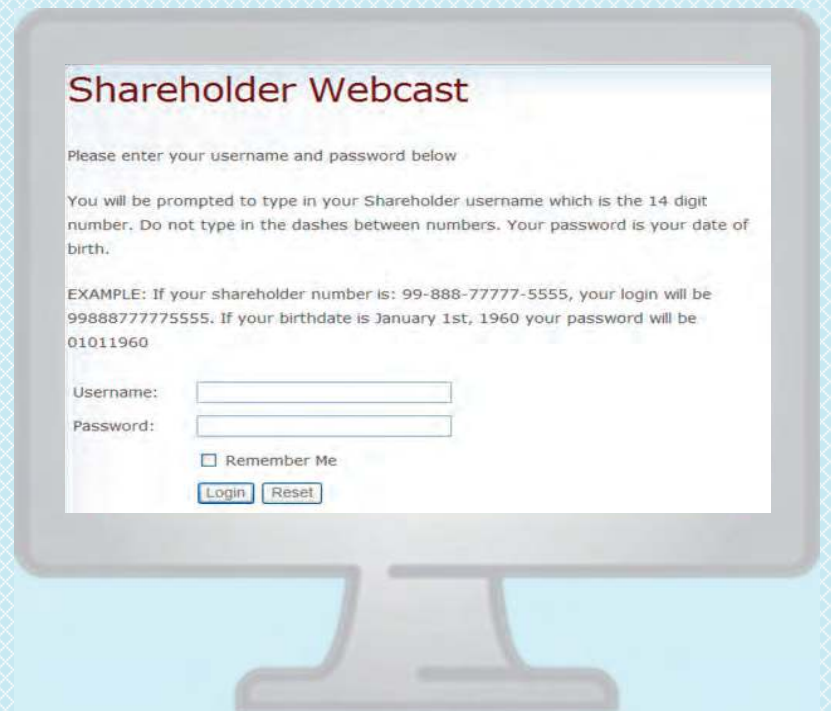
