In addition, shareholders approved a major milestone for the corporation: the resolution to open enrollment for lineal descendants and missed enrollees. With this decision, BSNC's Articles of Incorporation will be amended, allowing many descendants to enroll and receive 50 Class C shares, vote in corporate elections and governance, and access the benefits of shareholder ownership. Missed enrollees will now have the opportunity to enroll after many years of waiting.

"This moment is the result of more than a decade of thoughtful discussion and planning by the Board of Directors," said President Cindy Massie. "I want to extend my heartfelt thanks to our

shareholders—for voting, voicing your opinions, and staying engaged in the future of your corporation."

Over the coming months, staff will work to design the most efficient enrollment process. In the meantime, descendants are encouraged to begin gathering required documents, such as birth certificates. Additional details will be shared once finalized.

BSNC thanks the Board and staff for their dedication and hard work in achieving this milestone. Quyaana to our shareholders for participating and remaining engaged in shaping a stronger future for generations to come.

Beringia Settlement Trust Announces 2025 Shareholder and Elder Distributions

The Beringia Settlement Trust Board has declared a record-high distribution of \$13.25 per share. In addition, a \$1,550 Elder distribution has been approved for original shareholders aged 65 or older as of Nov. 1, 2025, the date of record. These distributions will be paid through the Beringia Settlement Trust and are not taxable. The distributions will be direct deposited or mailed on or before Nov. 15, 2025.

Additionally, BSNC is excited to announce that the Board has approved a plan to grow the Beringia Settlement Trust Permanent Fund as part of a multi-year strategy to increase shareholder benefits. This plan is intended to ensure distributions do not decrease as new shareholders are added through enrollment. As a forever fund, this reflects the Board's commitment to growing distributions for generations to come.

Shareholders can receive their distribution earlier than by mail by signing up for direct deposit through the MyBSNC portal at shareholder.bsnc.net. All shareholders are encouraged to verify their mailing and/or direct deposit information. Those preferring a check by mail should ensure their mailing address is up to date. For assistance,

Born and raised in Unalakleet, Gail is the daughter of Elizabeth "Betty" and Lowell Anagick and a descendant of Chief Nashalook, the last traditional chief and shaman of Unalakleet. Her upbringing instilled deep respect for Alaska Native culture, land, and community values—principles that have guided her lifelong dedication to advancing Alaska Native people.

A distinguished advocate and pivotal leader in Indigenous governance and economic sovereignty, Schubert transformed BSNC into a multimillion-dollar enterprise while fiercely protecting subsistence rights, promoting education, and empowering shareholders. Her legal and financial expertise, paired with her cultural grounding, enabled her to serve with both competence and care.

Schubert served on numerous statewide and national boards, including the Alaska Federation of Natives, ANCSA Regional Association, and Alaska Native Justice Center. A Stanford and Cornell alumna, she has always prioritized the next generation—creating internship programs, mentoring young leaders, and advocating for representation. Her legacy is one of transformative leadership, cultural stewardship, and unwavering dedication to community service.

Tyrone Southall

Tyrone Southall was raised with a traditional lifestyle. He fully embraces traditional values and embodies the Young Provider ideal through his actions every day. Southall started hunting from a young age. He happily shares his catch with Elders, family, friends, and his teachers. His passion for hunting and helping others has no end. He helps with processing whatever is caught and preparing food for storage. He can skin squirrels, foxes, beavers, wolverines, and wolves on his own. He mentors youth in his community by passing on traditional skills such as fox skinning and gathering friends to do healthy activities like basketball, biking, and swimming. His enthusiasm for including others in these activities reflects his strong leadership and commitment to his community's well-being. Southall values spending time with his family, learning from Elders in the community and sharing the joy of traditional living.

Southall was recognized in honor of the late Ralph Pirciq Ivanoff, an experienced fisherman dedicated to a subsistence way of life. Ivanoff was born June 12, 1923, in Shaktoolik to Paul and May Ivanoff. The eldest of 10 children. He grew up in communities across Alaska. A skilled hunter, fisher, trapper, and gatherer, he spent his days on the water and the tundra, teaching his children and grandchildren to harvest ugruk, walrus, caribou, moose, small game, and fish with respect and care. Ivanoff was a commercial salmon fisherman in Norton Sound for 58 years, beginning before the fishery was formally recognized by the state in 1961. His final season was in 2019, at the age of 96. He could understand and speak most Alaska Native languages and dialects from Bristol Bay to Barrow. Known for his humor, warmth, and endless storytelling, Ivanoff built friendships across Alaska and preserved cultural traditions through his words and his way of life.

Cain Seetook

This year, Cain Seetook began leading traditional dancing and singing every Friday during school hours, engaging all students at Kingikmiut School in cultural practice. The activity is entirely student-led and often rests on him. He can be found fixing drums, bringing them wherever he goes, and drumming or singing alone if needed. Beyond school, Seetook hunts and fishes, helps care for his younger siblings, hauls water and fuel for his family, and shares harvests with Elders and others in the community. Seetook also volunteers his time as a student coach for the Little Dribblers basketball team, inspiring younger students through sportsmanship and mentorship. Seetook is well on his way to becoming a community leader who carries forward the traditions and values of his ancestors while helping build a strong, modern community.

Seetook was recognized in honor of the late Cecilia "Punisiaq" Nunoork Amarok Smith, a respected culture bearer whose life was dedicated to teaching, preserving, and sharing traditional knowledge. Born on January 8, 1930, in Wales to Mary and Philip Nunoork, Smith carried a lifelong love for Alaska Native food, dancing, and her culture. Married to Joseph Amarok in 1953, she raised eight children in Nome before later making her home in Anchorage, Kasilof, and Wasilla. Smith was a proud member of the Kingikmiut Singers and Dancers of Anchorage and found joy in performing and passing on her traditional culture. She danced until nearly her last days, a reflection of her unwavering spirit and devotion to tradition. She loved preparing and eating traditional foods, and her deep cultural knowledge, generosity, and passion for community made her a beloved Elder. Her heart was open to all—family, friends, and community members alike. She was known for her warmth and laughter and was always on the go. She left an enduring legacy that continues to inspire her family and community.

Shareholder-Owned Business Spotlight: Oksuk Productions – Devan Otton

BSNC shareholder and owner of Oksuk Productions, Devan Otton was born and raised in Nome, Alaska. The son of Darrin and Sherry Otton, he has family ties to Shishmaref and Unalakleet and grew up with three older sisters. A graduate of Nome-Beltz High School, he attended the University of Alaska Fairbanks, completed a BSNC Internship in 2019 and a Nome Eskimo Community internship in 2020–2021, and now works as a Computer Network Technician for Norton Sound Health Corporation.

Otton's creative journey began when his parents gifted him a drone, sparking his passion for videography. Completely self-taught, he immersed himself in the work of online creators and developed a distinctive artistic style inspired by their work. His love for photography was first nurtured in his high school yearbook class with his favorite teacher, Mrs. Snell, where he learned to move beyond "point and shoot" and discovered how lighting, shutter speed, and composition could transform an image into art.

Otton's first drone film was submitted to the Alappaa Film Festival, and his photography has earned recognition in numerous photo contests, including first place in the Iditarod Fine Arts Show (2024), second in the BSNC Photo Contest for scenery (2024), selection for the Nome Arts Council Calendar (2024), second in the Alaska

Otton deepened his skills through film photography, starting with disposable cameras before investing in his own. The limitations of film taught him patience, technique, and intentionality. His advice to aspiring creators: keep practicing what you love and your hard work will pay off. Looking ahead, he is excited to film more basketball highlights for the Nome Nanooks and will continue telling stories through his lens.

BSNC is pleased to announce that Robert "Bobby" Evans has been elected Chair of the Board of Directors. Evans has served on the Board for the past 14 years and brings decades of leadership experience from across the Bering Strait region.

Born and raised in Nome, Evans grew up living a subsistence lifestyle and learned the values of humility, honesty, and hard work from his parents and grandparents. He attended Covenant High School in Unalakleet. His grandparents are Teddy Sockpick of Wales and Holly (Nayokpuk) Sockpick of Shishmaref. His mother, Laura (Sockpick) Evans, moved to Nome in the late 1960s and, together with his father, Bob, raised their five children. His Inupiaq name, Keok, honors his great-uncle Walter Nayokpuk of Shishmaref.

After a 21-year career with the State of Alaska, Evans retired in 2009 and went on to work with Kawerak, Inc., where he collaborated with communities and youth leaders across the Bering Strait region. He served nine years on his village corporation board, including six as Chair, before joining the BSNC Board.

Evans founded and operated Tundra Toyo and Heating, a successful Nome-based business, before selling it and relocating in 2019. He now owns and operates Tundra Business Solutions, a consulting firm providing business and marketing services to organizations across rural Alaska.

"I am humbled and honored to be elected as the next Chair of the Board," said Evans. "I do not take this responsibility lightly and will work hard to build on BSNC's successful path. We have a strong management team and many dedicated employees who make our corporation thrive. We all miss Chairman Henry Ivanoff, and I will do my best to carry forward his legacy. I remain committed to best business practices, professionalism, and respect for those around me."

Evans spent 45 years living and raising his children in the Bering Strait region. He now resides in Kenai with his wife, Kayleen Fayer-Evans, who is from the Bristol Bay region. Their four adult children and grandson live in Nome, Anchorage, and on the west side of O'ahu.
