BSNC Annual Meeting set

The 1984 Annual Meeting of Bering Straits Native Corporation will be held on Saturday, November 3, 1984 at 10:00 AM in the Convention Center in Nome for the following purposes:

1. Approval of Minutes;
2. Election of eight (8) Directors;
3. Amend the Articles of Incorporation to eliminate the shareholders' right of cumulative voting for directors;
4. Amend the Articles of Incorporation to provide that shareholders shall not have equal voting rights in board of directors elections but shall have equal voting rights in all other matters;
5. Amend the Articles of Incorporation and Bylaws to provide that one-third of the shares entitled to vote constitutes a quorum for a meeting of shareholders.
6. Ratification of payment of fees and per diem to directors;
7. Ratification of selection of independent accountants;
8. President's report, land report and other reports including financial and audit reports;
9. Such other business which properly comes before the meeting.

Only stock held by Native persons whose name appear on the stock registry of Bering Straits Native Corporation as of the close of business on September 30, 1984 will be entitled to vote at the meeting or any adjournment thereof.

Every BSNC shareholder will receive a packet of information including the 1984 Annual Report,



VERY IMPORTANT BUSINESS—At a September 10th meeting the BSNC Board of Directors met to approve the proxy statement, proxy cards and financial statements as part of the preparation for the November 3rd Annual Meeting.

Notice of 1984 Annual Meeting and Proxy Statement, proxy card or cards and a prize list. This packet was mailed on October 1st. Should you have any questions please do not hesitate to contact BSNC at (907) 443-5252 (no collect calls, please) or write to Box 1008, Nome, Alaska 99762. Be sure to read the entire Proxy Statement, it explains everything you need to know in detail.

Shareholders are urged to complete, date, sign and return promptly the proxy card. It is desirable that as many shareholders as possible be represented at the meeting. Consequently, whether or not you

expect to be present, please sign and return your proxy by October 31.

If you wish to attend the meeting and vote in person you may do so, even though you have previously mailed your proxy. You may revoke the proxy at any time before it is exercised.

Registration shall be 1:00 to 4:00 PM on Friday, November 2, 1984 and from 8:00 to 10:00 AM on Saturday, November 3, 1984.

Seven cash door prizes will be awarded at the 1984 BSNC Annual Meeting. To be eligible for the prizes, a voting shareholder must return his proxy card to BSNC be-

fore the Annual Meeting.

The 8 directors whose terms are up for election this year are: Ruben Bowman, At Large; Walter Seetot, Brevig Mission; Harry Boone, Golovin; Morris Kugzruk, Mary's Igloo; Tessie Peoples, Stebbins; Roger Otten, Sr., St. Michael; Blanche O. Walters and Vernon Olson, Sitnasuak.

On Friday evening, November 2nd, a potluck will be held at 6:00 PM at the Nome Elementary School. All BSNC shareholders and their families are invited to attend.

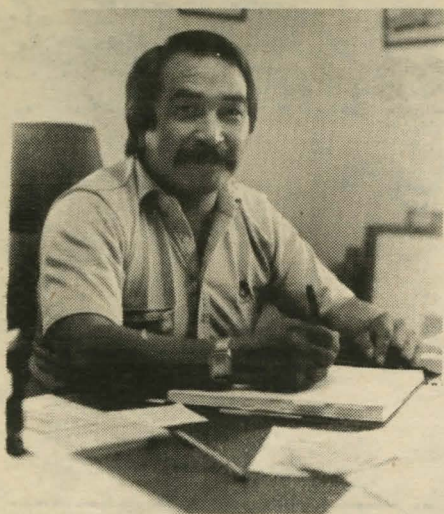
Take heart

From the President's Desk

Last Year at our annual meeting an amendment to the BSNC Bylaws and Articles of Incorporation was passed by the shareholders. The amendment allowed each village to have a seat on our board of directors. This amendment was passed overwhelmingly by 80% of those shareholders voting in the election. As you will read in the 1984 BSNC proxy statement, the issue must be voted on again because we need approval of 2/3 of the outstanding shares in order to change our Articles of Incorporation.

The restructured 24 member board of directors has progressed even better than our expectations. The expanded committee system has involved the entire board, and through them the villages provide the key decisions and planning for our region. As a result, the region is more unified.

If we are to keep the expanded board of directors and keep the villages involved in our board, then it is vital that we have at least 2/3 of all BSNC shareholders supporting this change in our Articles of Incorporation.

There have been many changes during the last year that we will be covering at the annual meeting. I hope to see you there.

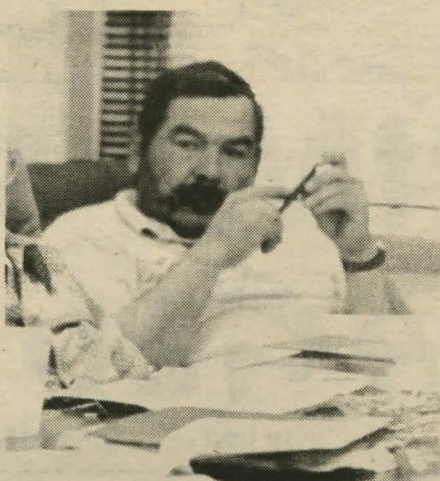

CHARLIE NELSON

Board Member of the Month

At Large board member Charlie Nelson has lived in Nome on two separate occasions. The first time he does not remember too well. In September 1945, World War II had just ended. Charlie's parents, Anna Jane and David Nelson, met in Nome during the war. Mr. Nelson worked with the army engineers. When peace came, the family decided to move on to Idaho Falls, Idaho with their two young sons. Born in May of 1945, Charlie was just four months old when he first left Nome. He was not to return until 1975, some thirty years later.

When Charlie was 5 years old, the family relocated in Park City, Utah. It is here where Charlie attended elementary school and high school. Park City is also where Charlie began to develop a serious interest in football. In his junior and senior years of high school, he played offensive guard and defensive end. His talent paid off. In 1962, Charlie attended the University of Utah in Salt Lake City with a full football scholarship. "That is where I found out how good I really was," smiles the now "retired" football player. "I played first string defensive end for two years. I was majoring in Art at the time."

Life continued. In late 1964 when the United States was in the midst of the Vietnam war, Charlie Nelson was faced with a common problem of the time. He had two choices: either get a job or get drafted.

Fortunately, Charlie got a job as a core driller for Boyle's Brothers Drilling Company. His work brought him to Nevada, Wyoming, Montana, Texas and finally, Colorado. He lived in Colorado for 10 years. There, Charlie worked as a union carpenter and finally as a millwright for the Adolph Coors brewing company. However, Coors soon developed a "biological problem" with their famous unpasteurized beer. The sales dropped and Charlie's job of installing precision machinery was ended.

"I had to move in order to find a job. So I figured, why not Alaska?" remembers Charlie. "After growing up Outside it was a shock to come back to Nome. But once I got here, I did not miss anything from the Outside life, especially the rat race and all of the people and all the traffic jams."

Upon returning to Nome, Charlie worked as a carpenter for the Alaska Gold Company which was just starting up after being shut down for several years. There was a lot of work to be done. Nelson helped to rebuild the pump station, camp No. 5 and dredge No. 6.

In February of 1984, Charlie was appointed to serve on the BSNC Board of Directors representing the 830 At Large shareholders. Since then he has learned "a great deal" about his regional corporation. "It will take a lot of work to make BSNC profitable again. Hopefully we will be able to save the corporation. Charlie Johnson is definitely doing a good job."

Nelson continues, "As far as the At Large shareholders are concerned, I don't know if they have any interest in their regional corporation. They may be disenchanted by the great losses that BSNC incurred in the 1970's."

Serving with Charlie Nelson as an At Large board member for BSNC is Ruben Bowman. Both of these board members want more involvement from the At Large shareholders. "Voice your concerns, ask questions about 1991. All At Large members are encouraged to contact us," urges Charlie.

Even though Charlie Nelson spent most of his life outside of Alaska, he comes from a prominent Fish River family. Charlie's mother Anna Jane Matthews was born on the river near Shaktoolik. Anna's father was Charlie Matthews, the older brother of Job Kokochuruk. Anna grew up living in Solomon, White Mountain and Golovin. Her parents Charlie and Ada Matthews and two of her three sisters died of tuberculosis in the 1930's leaving Anna Jane orphaned.

BSNC director nominees

This year, eight of the twenty-four directors of BSNC will be elected for three year terms. If you are a shareholder enrolled to Brevig Mission, Golovin, Mary's Igloo, Stebbins, St. Michael or At Large, then you will be electing ONE director. Those shareholders enrolled to Sitnasuak will elect TWO directors. Please vote only for the nominee or nominees from the village TO WHICH YOU ARE ENROLLED.

If you are enrolled to Council, Inalik, King Island, Koyuk, Shaktoolik, Shishmaref, Solomon, Teller, Unalakleet, Wales or White Mountain your village is NOT electing a director this year. The director representing your village is NOT up for election at this meeting. He or she will remain on the BSNC Board of Directors until his or her term expires. If you are enrolled to one of the above eleven villages you will receive a white proxy card from BSNC. Please vote on the 5 issues that are listed on the back side of your proxy card. It is important that you return your proxy card so that a quorum is reached at the BSNC Annual Meeting on Saturday, November 3rd.

Dollars & Sense

Understanding the Annual Report

Within the next few days, shareholders will be receiving proxy statements and proxy cards for the Bering Straits Native Corporation Annual Meeting to be held November 3, 1984. Along with the proxy statements and card you will be receiving a copy of the 1984 Annual Report.

To the inexperienced, and sometimes experienced reader, the Annual Report can appear to be nothing more than a jumbling of numbers. The intent of the Annual Report is to provide shareholders with a statement of condition of BSNC and a summary of the past year's activity. This article is intended to help you better understand the Annual Report.

The Annual Report is broken into three main statements accompanied by the Auditor's Report and Notes to the Financial Statements. I will explain these individually in the following paragraphs.

The Auditor's Report states items of specific interest to the Annual Report reader and explains the tests and procedures which were conducted during their review of the financial records.

The Balance Sheet states BSNC's financial condition as of the close of business on June 30, 1984. The Balance Sheet is broken down into the following three categories:

1. Assets - What BSNC owns
2. Liabilities - What BSNC owes to others
3. Capital - What the shareholders own after all liabilities have been subtracted from the assets.

The Statement of Operations and Deficit is a picture of the year's operations. The various sources of revenues and types of expenses are listed. Also listed is the accumulated deficit and an analysis of loss on a per share basis.

The Statement of Changes in Financial Position reports how activities of the corporation have been financed and how financial resources were used during the course of the fiscal year.

The fiscal year of BSNC is from July 1 through June 30. This statement shows the changes in working capital for the fiscal year. Working capital is the difference between current assets and current liabilities (current being those items due within the next year).

The Notes to the Financial Statements are included to give the readers a better understanding of the financial statements. The notes provide a more specific explanation of items in the financial statements.

I hope this will help you to better understand the Annual Report and obtain a more informed understanding of your corporation.
